

Bereaved children and families benefit from Buddy's Place on site. RPC hosts Basketball, Volleyball, Music Lessons, Choir, Bells, Ringers and Singers, PW, and The Messiah (!).

The church helped settle 2 refugee families in association with the Riverside Resettlement team and fed the many souls in transition once a month over the year at the Boulevard. We thought hard about how to make a difference, and how to sustain the mission of RPC in a changing world, and the answer included nesting New Life Community Church.

Our special celebrations were celebrated: the Strawberry Social, Wedding Sunday, PW, 150 Birthday Party. Ace & Vincent were baptized. God was thanked for the lives of the saints, and we celebrated their lives when they entered the cloud of witness. We remember with love Greta Schramm, Lynn Shannon Labotka, Wesley Sedlacek, Susanne Vogel, and Joyce Van Cura.

We leave a seminal and transitional year hopeful: hopeful in Christ, hopeful in one another, and hopeful that the communion of saints in Riverside and our work together, will bring forth the feast of heaven on earth: faith, enthusiasm, awareness, service, transformation.

## MINISTER OF MISSION AND OUTREACH

The Riverside-Area Refugee Resettlement Team, a greater version of the work the RPC and Ascension Lutheran have done together over the years, was able to partner with the resettlement of two families of six people each! Over \$12,000 was raised and both families had fully furnished apartments. Plus, we mentor the families and support their continued transition.

As the use of the Little Food Pantry increased so did our outreach to the community for support. Several groups did food drives and the Township increased giving from \$1,200 to \$5,000 this year. Seven new volunteers came on board to help with produce and/or stocking.

5th Sunday continued with partnerships with Ascension Lutheran and Compassion UMC. Each of us hosted one of the Sundays bringing the congregations together in service.

Managing these many projects and sharing them on our Facebook page, community pages, responding to messages, updating the website, etc. has resulted in significant recognition for who we are and what we do. It is nice to see someone post on the Riverside Community page "I'm new to town, what church has active mission?" and to see people who are not members of this congregation mention RPC and know what we are doing.

The focus of 2023 will be to strengthen all three of these signature programs in tandem with the Mission and Outreach committee.

It was my pleasure to coordinate the 150th Birthday activities for RPC which included a Wedding Sunday, Birthday Party and donation wall.

Sharing mini messages has been a highlight of the year!

In this first full year of service to RPC I have seen us continue to be a congregation who comes together to be transformed by the love of God and then extend that love to others through our actions.

## PRESCHOOL

The first half of 2022 brought several new students to preschool in January. It was nice to have more buddies enjoy the warm, loving, creative learning environment that is preschool at RPC. Fall brought enrollment to 22, closer to pre-pandemic numbers. Our goal for fall 2023 is 28 students.

DCFS certification took place in spring. We are recertified through spring 2025.

Staff changes brought Spanish to the program. This, along with our many special guests and walking field trips, really sets us apart from other preschools.

Preschool families are invited into our church family. For example, they are all invited to come to the Ice Cream Social to pick up their enrollment packets (and most did). The parents have joined the RRART. They participated in our Christmas Pageant. They are invited to worship for Preschool Sunday. And many families helped the newly reformed Ringers and Singers.

We were excited to host our first fundraiser in years - Breakfast With Santa and Marketplace in December. In late winter we will have an adults evening fundraiser.

There is really no way to describe how amazing this preschool is. Until I became a staff person I had absolutely no idea. Please consider following the Facebook page and/or coming for a visit to see for yourself!

## BOY SCOUTS AND CUB SCOUTS

RPC has sponsored Boy Scout Troop 24 since 1939, and Cub Scout Pack 24 for almost as long. At the end of 2022, the Troop had 41 scouts and 19 registered adults, including Scoutmaster Davis Flassing and Troop Committee Chair Carrie Staubus. The Pack had 71 scouts and 25 registered leaders. The Pack was led by Cubmaster George Condes and Pack Committee Chair Natalie Wetzel. Cyril Friend retired as the Chartered Organization Representative, and Susan Lynch began serving in this role for both the Pack and Troop. Troop 24 held a successful Pancake Breakfast, as always on the first Saturday in March. The Troop attended Camp Tesomas in Northern Wisconsin for a week of tent camping in July. Older scouts travelled to Northern Michigan for a week of sailing on Lake Michigan, with stops in Mackinac Island, Sleeping Bear Dunes and more. Weekend camping in 2022 included trips to Greene Valley Forest Preserve, Camp Owasippe, and Starved Rock State Park. Scouts earned the Horsemanship merit badge at Millbrook Ranch, attended the Princeton Civil War Re-enactment, and stayed in Eagle Cave. Other events included river-paddling on the Kankakee, hiking, orienteering, and various service projects. The Troop instructed scouts for Merit Badges including Cycling, Electricity, Art and Gardening. In 2022 seven Scouts achieved the Eagle rank. Pack 24 Cub Scouts camped at the Scout Cabin, Greene Valley and Warren Dunes. Cub Scouts also attended the Council Camporee and Camp Tecumseh. They enjoyed their annual Pinewood Derby, set records with this year's popcorn fundraiser, and celebrated their 70<sup>th</sup> anniversary.

The Scouts want to thank Riverside Presbyterian Church for its support, and we are happy to call RPC our home.

The end of RPC's 150th year found the congregation smaller in number, but still very strong in ministry and service, as is evident by the activities of the various committees and boards included in this Annual Report.

Session approved its first "nesting" church agreement by renting facilities for Sunday worship and weekday programs to the New Life Church, an outreach congregation of the Moody Bible Institute. It is hoped that some joint activities can take place in the future.

After discussion with members of Presbytery's Committee on Ministry (COM), the elders voted to not renew the contract of Rev. Mary Jo Dean, Interim Pastor, but to begin the search for a Called Designated Pastor. Mary Jo's last Sunday with us was November 20, and she was thanked for her service to RPC, especially in the area of Pastoral Care.

A Pastoral Nominating Committee (PNC) was elected by the Congregation and a Ministry Information Form submitted to Presbytery for approval, after which it will be posted for interested candidates to review.

As part of the transition process, Session retained Holy Cow! to conduct a survey to explore the congregation's views on who we are as a church, what we are called to do, and how well we are doing it, which will assist the PNC in its search. Session will also work with the Lombard Mennonite Peace Center to resolve conflicts which have arisen within RPC.

Worship services continue to be available for viewing on YouTube, and with technical assistance from New Life Church, it is hoped to be able to live-stream them in the near future.

We are grateful to Rev. Scott Matheny who is leading Sunday Worship Services and to Rev. Jonathan Krogh, who serves as Moderator for Session meetings while RPC is without its own Pastor.

Our studies for 2022 came from the Horizons book What My Grandmothers Taught Me: Learning from the Women in Matthew's Genealogy of Jesus. And also, beginning in August, Celebrating Sabbath: Accepting God's Gift of Rest and Delight.

Leadership of the nine lessons rotated among the Rev. Mary Jo Dean, Kate Chard, Sandy Kappmeyer, Elizabeth Musick, Sylvia Schade and Marilyn Slanec. Each meeting brings interesting information and stimulating discussion, as well as friendly fellowship. In November, 2022, we were saddened by the death of Joyce Van Cura, a long-time member. Joyce was an outstanding leader of the lessons for many years.

In 2023 we hope to continue our studies and expand the membership of the group -- open to all women -- as well as return to our format of a coffee hour preceding the study.

## FINANCE COMMITTEE

In 2022, the Finance Committee was a part of the Administration Hub, chaired by Susan Lynch. Members: Ben Dickerson, Ellen Hamilton, Doug Harvin, Will Vogel and Dennis Zander.

For 2022, the Per Capita paid to the Denomination was \$8,028 and we received \$3,645 from member contributions. Although the amount contributed by members was greater than in prior years, we need to continue to emphasize how detrimental this imbalance is to our general budget. Per Capita will be \$36.50 per member for 2023.

For 2022, the General Budget closed with a positive balance of \$5,113.42. However, because we received a contribution from savings of \$95,000 for operating cash, the real 2022 result was a deficit of (\$89,886.58). This deficit was approximately \$20,000 greater than the projected deficit of (\$70,037.58). Loss of membership from death and moving, diminishment of participation following two years of COVID, and substantial economic losses from market fluctuations all contributed to this problem. The General Fund received its anticipated annual Support Fund Contribution of \$26,179 in October (less than budgeted due to market losses).

The Preschool ended the year with a deficit of (\$33,395.33). The beginning of 2023 will mark the first full year with the normalized tuition model, which is currently bringing in approximately \$12,000 for each of 10 months. The Preschool is working towards increasing registration to capacity, which will further increase revenues. Nevertheless, we will need to watch this closely, as it places a great strain on working capital during the interim.

## MISSION AND OUTREACH

RPC hosted its ice cream social on July 20th. Given that we are still safety conscious, we adapted past practice and chose to bypass both having the cake sale and scooping ice cream. Instead we offered a variety of ice cream novelties and better-than-average store-bought cupcakes. The weather was gorgeous, and we had a very gratifying turnout including preschool families and many members of the community.

This fall, we again hosted documentaries at the Riverside library, one dealing with climate change, the other with the effects social media are having worldwide. The goal, and reason for hosting in a neutral site, was to reach out to members of the community and engage in conversations with them after viewing the films. But for the five films we have hosted, three before the pandemic and two this fall, a total of only 4 community members attended. Given that, we will likely review whether or not to continue this as an outreach program, but before reaching a conclusion we determined it best to first invest more effort into advertising them.

The committee served to support the two major missions of the church – refugee resettlement and the Little Food Pantry. Refugee resettlement expanded to include almost 300 people from the greater area. In 2023 the goal is to support one additional family while continuing to care for the two families we co-sponsored in 2022. The LFP expanded to daily produce this year which required additional volunteers. In addition, adopt-the-pantry was launched with local service organizations and clubs helping to fill the gaps in canned goods. We are also thankful to the Township of Riverside for increasing their support of the pantry.

In regard to allocating mission funds, we made the following recommendations, which were approved:

- RPC donated our portion of the Pentecost Offerings to The LeaderShop Organization-theleadershop.org
- RPC donated our portion of the Peace & Global Witness Offerings to RBHS, to sponsor a speaker for the students on how to build capabilities for addressing prejudice when they encounter it.
- RPC divided the general fund amount left after we complete our monthly support for the missionaries in Peru into four equal donations to four PC(USA) funds:
  - o Refugee and IDP Programs (International)
  - o Refugee emergencies (in the USA)
  - o Food Security (International)
  - World Mission (Mission personnel support)

We look forward to the coming year, with the changes it will likely bring, looking for new ways to serve our church and community.

## BOARD OF TRUSTEES

The Board of Trustees is responsible for all aspects of maintenance, repair and improvements to our historic church building and grounds. We operate within a budget, and for larger projects, under the approval of the Session. Our goal is to maintain a pleasant, safe and functional facility that serves our ministries and is also a welcoming resource for the community. It has been an honor to serve with a dedicated and hard-working board.

After the shut-down, activities began to get back to a regular schedule in 2022. During 2022, several projects were completed:

- the Trustees continued to replace certain lighting throughout the church building with high efficiency LED lights and/or fixtures. These upgrades included the preschool and the replacement of the gym lights to brighter high efficiency bulbs. With the increased use of the gym, these bulbs will pay for themselves in just a couple of years;
- the entire church was mulched including the North area which had minor landscaping done to improve drainage.
- New faucets in the men's and women's bathrooms by the fellowship hall.

In 2022 RPC entered into a shared use agreement with New Life Church and the Trustees have worked with New Life to coordinate the operation of the church facilities.

The Trustees have resumed All Church Work Days and have performed landscaping and routine maintenance on those days. The Trustees would again like to specially thank Jon Jansky who continues to perform countless repairs and upgrades in the church.

In an effort to control costs, a number of Trustees and other members of the congregation volunteered for snow removal duty. A special thanks to all of those that volunteered. As in prior years, the Trustees strive to do as much of the necessary work themselves in order to keep costs under control.

We are fortunate to employ a part-time custodian, Krzysztof Gieron, who completes routine cleaning inside the church. Members of the Board of Trustees perform larger cleaning projects as well as general repairs and maintenance throughout the year.

For 2023, the Trustees hope to continue improvements and required maintenance including the installation of a weather-enclosure on the office door to save on heating costs, improvements to the kitchen, additional lighting upgrades to energy efficient LED lighting and explore the possibility of upgrading the fire alarm system as well as an ADA compliant elevator system.
